AMENDMENTS AGREED TO

COUNCIL OF TRADITIONAL LEADERS AMENDMENT BILL [B 54-98]

CLAUSE 1

- 1. On page 1, in line 9, to omit "established by" and to substitute "referred to in".
- 2. On page 1, after line 9, to insert the following paragraph:

(c) by the substitution for the definition of "House" of the following definition:

"'Provincial House' means any House of Traditional Leaders which is established by provincial legislation under section 2 12(2)(a) of the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996), or which was established by provincial legislation as contemplated in section 239 of the said Constitution, as the case may be:".

CLAUSE 2

Clause rejected.

NEW CLAUSE

1. That the following be a new Clause to follow Clause 1:

Substitution of section 2 of Act 10 of 1997

2. The following section is hereby substituted for section 2 of the principal Act:

"Establishment of council

2.(1) There is hereby established a council to be known as the **[Council]** National House of Traditional Leaders.

(2) The [Council] <u>National House</u> shall consist of members nominated as provided in section 4.".

CLAUSE 4

Clause rejected,

NEW CLAUSE

1. That the following be a new Clause to follow Clause 3:

Substitution of words in Act 10 of 1997

- 4. The Principal Act is hereby amended—
- (a) by' the substitution for the word "Council", wherever it occurs, except in section 15, of the words "National House"; and
- (b) by the substitution for the words "House" and "Houses", wherever tley occur, except m section 1, of the words "Provincial Iouse" and "Provincial Houses", respectively.

NEW CLAUSES

1. That the following be new Clauses to follow Clause 4:

Substitution of long title of Act 10 of 1997

5. The following long title is hereby substituted for the long title of the principal Act:

"To provide for the establishment of a council to be known as the National House of Traditional Leaders; to provide for the objects and functions of the National House of Traditional Leaders; and to provide for matters related thereto.".

Construction of references to Council of Traditional Leaders

6. A reference in any law or document to the Council of Traditional Leaders shall be construed as a reference to the National House of Traditional Leaders.
