On page 4, in line 40, after "are" to insert:

South African citizens and persons who are

1. On page 4, in line 45, after "section" to insert "and section 6".

CLAUSE 8

1. On page 6. in line 48, to omit "to leave the Republic".

CLAUSE 11

- 1. On page 8. in line 29, after "register" to insert:
 - , in consultation with the person concerned
- 2. On page 8. from line 31, to omit subsections (3) and (4).

CLAUSE 17

1. On page 10. in line 34, to omit "without delay".

CLAUSE 18

- 1. On page 12, from line 12, to omit ". or fail to hand it over or send it as soon as practicable to the person to whom it belongs or the Director-General".
- 2. On page 12, from line 23, to omit paragraph (h) and to substitute:
 - (h) at any time after a new identity card was issued to him or her, regain possession of an identity card previously issued to him or her under this Act or under an Act repealed in terms of section 25, or without lawful cause refuses to return for cancellation that previous identity card to the Director-General within 14 days after a written request to return such identity card was served upon him or her, or after he or she regained possession of the previous identity card, as the case may be; or
- 3. On page 12, from line 37, to omit paragraph (c) and to substitute:

(c) without lawful cause refuses to comply with a provision of section 10or 15(1); or

CLAUSE 22

- On page 16. from line 22, to omit subsections (2) and (3) and to substitute:
 - (2) Notwithstanding the provisions of subsection(1). the Director-General may furnish any information in respect of a person whose name is included in the population register to—
 - (a) any person or institution on behalf of, and on the written instruction of. any such person:
 - (b) any State department. municipality or statutory body;
 - (c) any organisation. body. society or institution whose main activity is insurance business as defined in the Insurance Act, 1943 (Act No. 27 of 1943), or banking as contemplated in the Banks Act, 1990 (Act No. 94 of 1990); or
 - (d) any other organisation. body, society or institution, subject to the restrictions. conditions. exclusions, directives and fees as may be prescribed.
 - (3') No information may be furnished to any organisation, body. society or institution contemplated in subsection (2) unless the information is required for the exercise or protection of any rights, is in the public interest. or is for the compilation of a voters' roll.
