BILL

To provide for the recognition of national and provincial organisations representing the different categories of municipalities; to determine procedures by which local government may designate representatives to participate in the National Council of Provinces; to determine procedures by which local government may consult with national and provincial government; to determine procedures by which local government may nominate persons to the Financial and Fiscal Commission; and to provide for matters connected therewith.

PREAMBLE

SINCE the **Constitution requires an Act of Parliament to provide** for the recognition of national and provincial organisations representing municipalities;

AND SINCE the legislation must determine procedures by which local government may consult with national and provincial government, designate representatives to participate in the National Council of Provinces and nominate persons to the Financial and Fiscal Commission.

B E IT THEREFORE ENACTED by the Parliament of the Republic of South Africa, as follows:—

Definitions

1. (1) In this Act, unless the context indicates otherwise-

- (i) "Minister" means (he Minister for Provincial Affairs and Constitutional 5 Development; (i)
- (ii) "national organisation" means the organisation recognised in terms of section 2(1)(a); (ii)
- (iii) "provincial organisation" means an organisation recognised in terms of section 2(1)(b); (iii)

(iv) "responsible member" means the member of the Executive Council responsible for local government in the province in question. (iv)

(2) For the purposes of this Act and for as long as item 26(1)(a) of Schedule 6 to the Constitution applies, the following are the categories of municipalities:

- (a) Municipalities established for a metropolitan area as defined in section 1 of 15 the Local Government Transition Act, 1993 (Act No. 209 of 1993);
- (b) municipalities as defined in section 9A of the Local Government Transition Act, 1993 (Act No. 209 of 1993);
- (c) any local council as defined in section 10B of the Local Government Transition Act, 1993 (Act No. 209 of 1993).

Recognition of national and provincial organisations

2. (1) Subject to section 5, the Minister must, by notice in the Gazette-

(a) recognise one national organisation representing the majority of the provincial organisations contemplated in paragraph (b); and

- (b) with the concurrence of the responsible member, recognise one organisation in each province representing the majority of municipalities in the province in question: Provided that all the different categories of municipalities in the province in question are represented in the organisation in question.
- (2) (a) The Minister may withdraw any recognition referred to in subsection (1) if -5
 - (i) the organisation ceases to represent the organisations or municipalities as contemplated in subsection (1) or ceases to comply with any of the criteria contemplated in section 5; and
 - (ii) the Minister gives the organisation in question 30 days notice 01' the intended withdrawal.

(b) If the Minister withdraws the recognition of 'an organisation contemplated in subsection (1)(b), he or she must act with the concurrence of the responsible member.

Designation of representatives to National Council of Provinces

3. (1) The designation of representatives as contemplated in section 67 of the Constitution lakes place at an executive committee meeting of the national organisation. I 5

(2) The head of the national organisation must at least 14 days before the executive committee meeting request every member of the national organisation to nominate in writing persons for designation as representatives.

(3) If the number of nominations are not greater than the number of representatives to be designated, the head of the national organisation declares the nominated persons to be 20 duly designated.

(4) if the number of persons nominated is greater than the number of representatives 10 be designated, a secret ballot must be held.

(5) The designation of any representative may be withdrawn by the executive committee, and any vacancy filled in accordance with subsections (1), (2), (3) and (4).25

(6) The head of the administration of the national organisation must inform the Secretary of the National Council of Provinces in writing of any designation made or withdrawn,

Consultation procedure

4. (1) Consultation between the national organisation and the national and a 30 provincial government takes place at a meeting convened by the Minister.

(2) The Minister may invite any of the provincial organisations to the meeting contemplated in subsection (1).

(3)Despite subsection (1), the national organisation may at any time approach any Minister to consult with the national government.

(4) A provincial organisation may only consult the national government after consultation with the national organisation.

(5) Consultation between a provincial organisation and the provincial government in question takes place at a meeting convened by the responsible

Regulations

6. (1) The Minister may, after consultation with the responsible members and having regard to principles of transparency and equity, make regulations determining criteria other than those contemplated in section 2, for the recognition of the organisation referred to in section 2(1)(a) and the organisations referred to in section 2(1)(b).

(2) The Minister must, in determining the criteria contemplated in subsection (1), take into account all relevant factors, including—

(a) political inclusiveness;

(b) provincial representiveness;

(c) a balance between urban and rural municipalities.

Repeal of law and transitional arrangement

7.(1) Subject to subsection (2), section 10F of the Local Government Transition Act, 1993 (Act No. 209 of 1993), is hereby repealed.

(2) Any organisation recognised under section 10F of the Local Government Transition Act, 1993 (Act No. 209 of 1993), immediately before the coming into 15 operation of this Act, is deemed to have been recognised in terms of section 2 of this Act.

Short title

8. This Act is called the Organised Local Government Act, 1997.

MEMORANDUM ON THE OBJECTS OF THE ORGANISED LOCAL GOVERNMENT BILL, 1997

Section 163 of the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996), determines that an Act of Parliament must provide for the recognition of a national organisation and provincial organisations representing municipalities, and must determine procedures by which organised local government may designate representatives to the National Council of Provinces (NCOP) and nominate persons to the Financial and Fiscal Commission (FFC).

In order to comply with the provisions of section 163 of the Constitution, clause 2 seeks to make provision for the recognition of a national organisation and nine provincial organisations 10 represent local government.

Clause **3 seeks** to provide for the designation by the national organisation of representatives to participate in proceedings of the NCOP. Local government's participation in the NCOP is important as this will ensure that local government will for the first time participate in the law making process when local government issues are at stake.

Clause 4 seeks to provide for procedures by which the national organisation and provincial organisations may consult with the national and a provincial government.

Clause 5 proposes the nomination of two persons by the national organisation for appointment by the President as members of the FFC in terms of section 221 of the **Constitution. Municipalities arc** dependent on sufficient funds to perform their functions. The participation of local government in the FFC is therefore of the utmost importance as the FFC is *inter alia* responsible for making recommendations to Parliament in respect of the equitable division of revenue raised nationally among the national, provincial and local spheres of government.

Clause 6 seeks to empower the Minister for Provincial Affairs and Constitutional Development to make regulations prescribing criteria which have to be taken into account when the national organisation and nine provincial organisations arc to be recognised.

The Department of Constitutional Development and the State Law Advisers arc of lhc opinion that the Bill must be dealt with in terms of the procedure set out in section 76 of the Constitution.
