BILL

To abolish the Public Service Commission and the provincial service commissions concerned; and to provide for incidental matters.

B E IT **ENACTED** by the Parliament of the Republic of South Africa, as follows:—

Abolition of Public Service Commission and provincial service commissions concerned

1. The Public Service Commission established by section 209(1) of the Constitution 5 of the Republic of South Africa, 1993 (Act No. 200 of 1993), and the provincial service commissions established by the Provincial Service Commission Act, 1994 (Act No. 1 of 1994 of Northern Province), the North West Provincial Service Commission Act, 1994 (Act No. 2 of 1994 of North-West), the Provincial Service Commission Act, 1994 (Act No. 3 of 1994 of Free State), the Northern Cape Provincial Service Commission Act, 10 1994 (Act No. 3 of 1994 of Northern Cape), the Provincial Service Commission Act (Eastern Transvaal), 1994 (Act No. 3 of 1994 of Mpumalanga), the Provincial Service Commission Act, 1994 (Act No. 3 of 1994 of Gauteng), the Western Cape Provincial Service Commission Law, 1994 (Act No. 5 of 1994 of Western Cape), the Provincial Service Commission Act, 1994 (Eastern Cape) (Act No. 5 of 1994 of Eastern Cape) and 15 the KwaZulu-Natal Provincial Service Commission Act, 1994 (Act No. 6 of 1994 of KwaZulu/Natal), are hereby abolished.

Short title and commencement

2. This Act shall be called the Abolition of Public Administration Commissions Act, 1997, and shall come into operation on a date fixed by the President by proclamation in 20 the *Gazette*.

MEMORANDUM ON THE OBJECTS OF THE ABOLITION OF PUBLIC ADMINISTRATION COMMISSIONS BILL, 1997

The object of this Bill is to comply with item 24(2) of Schedule 6 to the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996).

The said item requires that the Public Service Commission and the provincial service commissions are to be abolished by an Act of Parliament passed in terms of section 75 of the new Constitution.
