## THIRTY- SECOND AMENDMENT OF THE CIVIL AVIATION REGULATIONS, 1997

The Minister of Transport has under section 22 (1) of the aviation act 1962 (act No 74 of 1962) made the Regulations in the schedule hereto

#### **SCHEDULE**

#### 1. Definition

### 4. Short title and Commencement
