I. INTRODUCTION

This is the eighteenth report produced by the Independent Complaints Directorate (ICD) to be tabled before Parliament. The report seeks to present a factual analysis of cases of non-compliance with the Domestic Violence Act (DVA) by members of the South African Police Service (SAPS) and the recommendations made to address same. The type of cases of non- compliance with the DVA covered in this report include failure to effect warrants of arrest, failure to advise complainants of options (e.g. failure to advise complainant to lay a criminal charge or apply for a Protection Order or both), failure to assist complainants, failure to furnish a subpoena and failure to serve a Protection Order.

The highest number of non-compliance matters was received in **Gauteng** with the total of 17 cases. The second highest number was reported in **Free State** with a total of 13, followed by **Western Cape** with 9 cases; **North Cape** received 8 cases and **Mpumalanga** and **Eastern Cape** received 3 cases respectively. **KZN** and **North West** received 2 cases each, **Limpopo** only received one case.

The total number of allegations of non-compliance matters received by the ICD was **58** cases. It is, however, interesting to note that several cases of non-compliance with the DVA were recorded across all provinces; there were limited applications for exemption from internal prosecution received. Only **24** applications for exemption were received by the ICD.

This report also seeks to highlight various proactive oversight engagements undertaken by the ICD during the period under review with a view to promote compliance with the DVA. These activities were in the form of awareness campaigns, workshops and DVA station audits. The ICD will continue to embark on these activities to enhance its efforts towards ensuring a successful implementation of the Domestic Violence Act, 116 of 1998.

This report was compiled based on the Monitoring Tool that was developed for the purpose of evaluating the stations equally and measuring them against the Domestic Violence Act and National Instructions.

This report will also show how some provinces made the effort to visits stations more than once to determine if the inspections conducted by the ICD had any effect on the compliance of the stations. It was however noted that a clear conclusion could not be reached. This was mainly due to the fact that members in the SAPS are very mobile; ICD members reported that they seldom find the same members available in the CSC and that led to the fluctuation of the percentage stations scored during this process.

Police Stations still seem to have challenges in implementing the Domestic Violence Act. Many of the members interviewed indicated that they require DVA training. This serves as an indication that the communities must be in an even greater need for education in this field. Empowering the communities is still one of the main areas to focus on, in opposing domestic violence.

2. THE MANDATE OF THE ICD IN RESPECT OF INCIDENTS OF NON-COMPLIANCE WITH THE DOMESTIC VIOLENCE ACT, 116 OF 1998

In terms of the South African Police Service Act 68 of 1995, the ICD is empowered to investigate all cases of misconduct against the SAPS and the MPS, including the following categories of offences and misconducts:

- I. Where a member kills or causes the death of any person involved with him/her in a domestic relationship, such as a spouse.
- II. Where a member commits an offence such as assault, rape, etc. against a person in a domestic relationship with the member, such as a spouse.
- III. Where a member refuses to assist a victim of domestic abuse.

In terms of the Domestic Violence Act 116 of 1998, failure by a member of the South African Police Service to comply with an obligation imposed in terms of this Act or the National Instructions referred to in subsection (3), constitutes misconduct as contemplated in the South African Police Service Act 68 of 1995 and the Independent Complaints Directorate, established in terms of the said Act must forthwith be informed of any such failure reported to the South African Police Service. Furthermore, the ICD must, every six months, submit a report to Parliament regarding the number and particulars of matters reported to it in terms of subsection (4)(a), setting out the recommendations made in respect of such matters.

In essence, the SAPS are obliged to report to the ICD all misconduct cases pertaining to non-compliance with the DVA. The ICD could in turn exempt members where a valid explanation for non-compliance is offered. Where exemption is refused, the ICD could investigate or

ask the SAPS to investigate with the ultimate purpose of holding a disciplinary hearing. The ICD's power to investigate incidents of noncompliance with the DVA is derived from the SAPS Act referred to above. Non-compliance constitutes misconduct and the Act empowers the ICD to investigate both offences and misconducts. In other words, non-compliance misconducts are equivalent to misconducts categorized as Class 4 cases by the ICD.

3. CASES OF NON-COMPLIANCE WITH THE DVA AND THE PARTICULARS THEREOF

In terms of the Domestic Violence Act, the ICD is obliged to report to Parliament regarding the number of cases of non-compliance with the DVA received and the particulars thereof and also set out how it dealt with recommendations of such matters.

The following statistics relate to cases of non-compliance received from I January to 30 June 2009 and are analyzed according to provinces.

3.1. EASTERN CAPE

Eastern Cape received three (3) complaints of non-compliance with the DVA. The particulars thereof were as follows:

7. CONCLUSION

This report is the eighteenth report the ICD has prepared since the monitoring of the implementation of the Domestic Violence Act has been added to our mandate. SAPS have embarked on training all members on the Domestic Violence Act, but stations indicated to ICD members that are still in need of training. It is apparent that future training should concentrate on the administrative part of the Domestic Violence Act as well, since it seems that to be the reason why stations do not comply with the Act and National Instructions.

The ICD received more applications for exemption than in the past but this is still not satisfactory. It is also a concern that SAPS management does not respond in instances where the recommendations are for them to take the necessary disciplinary action. This means that acts of blatant non-compliance go unpunished.

The ICD has found that the Monitoring Tool used in this report assisted in ensuring the Stations are treated equally in their performance and implementation of the Domestic Violence Act. It also assisted in repeat visits by the ICD and it has shown that some stations improved and others who did not expect a follow-up visit relaxed the criteria, which was evident in their readiness.

The ICD has during the period January to June 2009 embarked on DVA station audits, Workshops with the SAPS and stakeholders and Community Outreach initiatives to assist and monitor the implementation of the DVA.

In this period **58** cases of non-compliance were reported to the ICD and from this number only **25** applications for exemption were received. Of theses **24** applications were granted and in one (1) case exemption was not granted, the member was disciplined. The SAPS are complying at about **43**% in terms of forwarding applications for exemption to the ICD. This is an improvement on the 23% of the previous period.

The ICD audited **283** police stations and found that **50** stations were complying on a level of Non-Compliant (0-49%). A further **95** stations were complying on a level of Fairly Compliant (50-79%), **104** stations were on the level of Substantially Compliant (80-99%) with their implementation of the DVA. Thirty-four (**34**) stations were Fully Compliant (100%) with the Domestic Violence prescripts.

The challenges that were identified were in relation to the lack of understanding the SAPS members have in terms of completing the DVA registers and forms. Record keeping is a challenge for the members and this was apparent when the stations were audited. It was found that one station might be doing well on one visit and when the station was visited again a few months later the records were either misplaced or not maintained as they should be, that is seen in the changes of the allocated scores they obtained during each visit. A number of stations managed to improve their compliance and others did so only temporarily. We should create a culture that would encourage the compliance with the implementation of the DVA. Station Commissioners should make a renewed effort to educate their members in terms of the DVA and National Instructions. This would also have to include an effort on their part to inspect registers regularly to ensure compliance. It was also noted that several stations do not have a victim friendly care centre in place or that it is not available at all hours. There are several issues that this report points out that can be rectified with little effort, e.g. by having the necessary documentation available at the station in order to assist victims of domestic violence, other matters might have more substantial resource implications, but even then some effort should be made to obtain such resources.

The ICD managed to conduct **20** workshops with stakeholders in five provinces, Gauteng, KwaZulu-Natal, Mpumalanga, North West and Western Cape. North West managed to conduct 5 workshops in order to discuss what is expected of members and to assist them where possible in this task. It is recommended that SAPS should conduct DVA Workshops internally, to continually sensitize their members in this regard.

Community outreach activities were also arranged where the mandate of the ICD was explained in full as well as the role the SAPS plays in the process. Nationally **103** events were arranged and ICD attended these events, reaching approximately **10 000** community members. In addition the Provincial Heads of Mpumalanga and Western Cape also had radio slots and interviews where they were able to answer the questions of listeners and educate them of their rights in terms of the DVA.

This report indicates that the SAPS have made some progress in implementing the Domestic Violence Act and National Instructions. ICD provincial offices made more effort during this period to obtain applications of exemption from SAPS, but still the rate of receiving applications is less than ideal. It is desirable that the complaints on allegations of non-compliance should match the rate of applications for exemptions received.

The situation around the 508 registers is a concern, the fact that records are not maintained properly raise questions over the SAPS and Metro Police's commitment to deal effectively with DVA matters.

The ICD is committed to assisting the SAPS in implementing the DVA successfully in South Africa and will continue to monitor the implementation of the Domestic Violence Act.
