PREFACE

This report contains tourism statistics for South Africa.

The report distinguishes between statistics on South African citizens/residents from those on foreign travellers.

For South African citizens/residents two sources of information are used: The information obtained by scanning the bar codes in their passports, whenever they go across a port of entry/exit, and the departure forms (B1-117) they fill in when they depart through either Johannesburg, Durban or Cape Town international airports.

For foreign travellers information from their passports and arrival forms are captured on the computer at the port of entry. Subsequently, stickers containing bar codes are affixed on their passports. Upon departure the bar codes are scanned at the port of exit, eliminating the need to fill in departure forms.

For foreign travellers the arrival statistics are disaggregated by the following: Purpose of visit by month of arrival; mode of travel and place of entry; country of permanent residence by month of arrival; mode of travel and place of entry and duration of stay by month. For departing foreign travellers, and for returning South African residents the statistics are disaggregated by mode of travel and place of departure. For South African residents departing temporarily the statistics are broken down by purpose of visit, month of departure and by the international airport from which the person departed.

Tourism statistics are also published in the quarterly *Bulletin of Statistics* and in the monthly Statistical Release P0351: *Tourism and Migration*.

Introduction

This annual report presents data on arrivals to and departures from South Africa (SA) both from a historical perspective and during the year 2002. The report distinguishes between visits to SA by foreign travellers and foreign visits undertaken by South African residents. Collectively, these figures on arrivals and departures constitute tourism statistics.

Historical trend in tourism

For most of the 1970s and 1980s the trends in the numbers of arrivals and departures of foreign travellers are fairly similar in pattern. Figure 1 shows that prior to 1986, the trend in the number of arrivals and departures remained reasonably steady at around 500 000 per annum. From 1986 to 1990, there was a gradual increase in the number of foreign travellers to SA and between 1990 and 1993, the rise was very steep. After 1993 the pace of increase in arrivals continued, but there was a marked lag between the number of arrivals and the number of departures, during the 1970s and 1980s there were discontinuities in the collection of data on foreign travellers. For example, from December 1980 to October 1991, data in respect of citizens from Botswana, Lesotho and Swaziland were excluded in the tourism statistics collected. Data from citizens of these countries were then included in the tourism statistics after October 1991, but contract workers from these countries were still excluded from the statistics. It was only in January 1992 that particulars of contract workers and those granted border traffic concessions were included in the tourism data. Data regarding citizens of Namibia were only included in the tourism statistics as from 1 January 1991, when formal immigration control between SA and Namibia was established. We are, therefore, dealing with two discrete periods, i.e. the period before 1990 and the period after 1990.

Figure 2a shows the trend in arrivals and departures of South African residents from 1970 to 1989, and Figure 2b shows the same trend for 1990 to 2002. In general, the trend in departures matches that in arrivals showing that many South African residents departing temporarily did return back to SA. However, after 1992 there was a marked increase in the number of South African residents making temporary visits out of SA. It must however be noted that the discontinuities described above also hold for these statistics. For example, when residents from Namibia were included in the tourism statistics prior to January 1991, they would fall under the category 'Residents' and when they were subsequently excluded, they would fall under the category of 'Foreign travellers'.

Foreign travellers to SA during 2002

Summary of totals

During 2002, the number of foreign travellers to SA was 6 549 916, a decrease of 10,9% compared to 2001. The highest number of foreign arrivals was recorded in the summer month of December while the lowest number of foreign arrivals was recorded in the winter month June.

During 2002, 1 862 460 overseas travelers visited SA. The 2002 figure represents an increase of 19,5% over the 2001 figure of 1 558 325. From mainland Africa, the number of travellers visiting SA, was 4 513 694. This figure represents a 7,6% increase compared with the 2001 figure of 4 193 732.

Mode of travel and ports of entry

During 2002, as many as 3 967 089 (68,1%) foreign travellers arrived in SA by road, followed by arrivals by air, 1 815 721 (31,2%). Less than 0,1% arrived by rail or sea. Figure 3 shows this distribution by ports of entry. Of the total number of foreign travellers arriving by air, 1 492 360 (79,2%) arrived through Johannesburg International Airport, while 369 638 (19,6%) arrived through Cape Town International Airport, 9 386 (0,6%) arrived through Durban International Airport and 11 848 (0,6%) arrived through other airports. For foreign travellers arriving by sea, 11 394 (63,2%) came through the Cape Town Harbour, while 128 (0,7%) used Port Elizabeth Harbour. Lastly, for foreign travellers arriving by rail, the majority 154 (2,4%) passed through the Lesotho border.

In departing from SA, the most common mode of travel used by foreign travellers was road, involving 3 967 089 (68,1%) person-trips, followed by air travel, involving 1 815 721 (31,2%) person-flights. Of the total number of foreign travellers departing by air, 1 429 779 (78,7%) departed through Johannesburg International Airport, 361 080 (19,9%) departed through Cape Town International Airport, 9 898 (0,5%) through Durban International Airport and 14 964 (0,8%) through other airports.

There were 1 554 300 air arrivals from overseas in 2002, which accounts for 83,5% of all overseas arrivals. The number of overseas travellers arriving by road was 287 940 (15,5%), followed by sea was 12 302 (0,7%) and the number arriving through rail or an unspecified mode of travel was 7 918 (0,4%).

The total number of travellers who arrived by road during 2002 from mainland Africa was 4 184 178 (92,7%). The number arriving by air was 321 252 (7,1%) and those arriving by sea, rail or an unspecified mode of travel was 2 668 (0,1%).

Country of residence

While foreign travellers come from many different parts of the world, there are a few leading source countries from which a large number of foreign travellers come. In order to bring out some salient aspects of source countries, the countries of origin have been grouped into two categories: overseas and mainland Africa.

Figure 4 shows the distribution of foreign travellers from mainland Africa by leading source countries in the year 2002. For this year, the leading source countries were: Lesotho, 1 162 786 (25,9%); Swaziland, 788 842 (17,5%); Botswana, 782 189 (17,3%); Mozambique, 579 768 (12,8%); Zimbabwe, 612 543 (13,6%); Namibia, 217 077 (4,8%) and Zambia, 123 081 (2,7%).

When comparing arrival figures from mainland Africa for 2001 and 2002, there were increases in the number of travellers arriving from the following countries: Zambia, (27,3% up from 96 666 in 2001), Malawi, (23,0% up from 77 680 in 2001) and Zimbabwe, (22,1% up from 501 698 in 2001). For the same comparison period, of the leading mainland African countries, those that had decreases in the numbers of arriving travellers were: Lesotho (9,7% down from 1 288 160 in 2001) and Namibia (1,1% down from 206 022 in 2001).

Figure 5 shows that during 2002, the number of travellers from the UK visiting SA was 449 088 (23,4%), making it the leading country of origin of overseas travellers. This was followed by travellers from Germany, 253 411 (13,6%). The other main countries of origin of overseas travellers were: the USA, 187 681 (10,1%); France, 114 797 (6,2%); the Netherlands, 111 873 (6,0%); Australia, 70 856 (3,8%); Italy, 48 329 (2,6%) and Belgium, 40 023 (2,1%). On comparing the figures for 2002 with those of 2001, the highest increase in the number of arrivals from these leading source countries was for France, (34,0% up from 85 663 in 2001) and Italy, (28,7% up from 37 565 in 2001). Traditionally, the leading source country for travellers from overseas has always been the UK and this did not change during 2002.

The purpose of visit

Figure 6 shows that, of the overseas travellers visiting SA during 2002, 1 601 826 (86,0%) reported that they were in SA on holiday, while 149 896 (8,0%) reported that they were on business trips. Similarly, Figure 7 shows that of the travellers from mainland Africa visiting SA during 2002, 3 984 746 (88,3%) reported that they were in South Africa on holiday, and 294 102 (6,5%) reported that they were on business trips.

During 2002, those visiting South Africa for the purpose of work (including contract work) numbered 38 051 (2,0%) among overseas arrivals, and 78 476 (1,7%) among arrivals from mainland Africa. Figure 8 shows that among the travellers from mainland Africa who stated upon arrival that they were on holiday, the largest numbers came from Lesotho, 1 162 786 (25,8%); followed by Swaziland, 788 842 (17,5%) and Botswana, 782 189 (17,3%). Figure 9 shows that the three leading mainland African countries from which business travelers came were: Lesotho, 136 282 (46,3%); Zimbabwe, 28 910 (9,8%) and Namibia, 27 420 (9,3%).

For holiday-makers from overseas, Figure 10 shows that during 2002 the highest number came from the UK, 400 897 (25,0%), followed by those coming from Germany, 233 718 (14,6%) and those coming from the USA, 156 483 (9,8%). For overseas travellers on business trips the highest number during 2002 again came from the UK, 33 722 (22,5%). However, the second highest number came from the USA, 18 812 (12,6%), followed by those coming from Germany, 11 366 (7,6%), as shown in Figure 11.

Duration of stay

In this report, the duration of stay of foreign travellers has been grouped into 10 categories: less than a day, 1 day, 2 to 7 days, 15-31 days, 32 to 90 days (1 to 3 months), 91 to 180 days (3 to 6 months), 181 to 270 days (6 to 9 months), 271 to 365 days (9 months to 1 year) and

more than 365 days (more than a year). These breakdowns are provided for each month of arrival. The data show that the distribution of these different durations of stay does not change much from month to month. The most frequent duration of stay is for 3 to 6 months (mostly above 20%) followed by 1 to 3 months and 2 to 7 days (each comprise mostly between 11% and 13%).

Arrivals and departures of South African residents in 2002

Totals, purpose of visit and mode of travel

During 2002, the total number of South African residents who departed 'temporarily' (through all ports of exit) was 3 793 672, an increase of 1,6% compared to the number of South African residents who departed temporarily during 2001. Of these departing South African residents, the number who travelled by air was 1 253 082 (33,0%). Of those who travelled by air and left through the three international airports of Johannesburg, Cape Town and Durban, 728 663 (58,1%) filled in departure forms. From the completed departure forms for the year 2002, one can see that, on the whole, South African residents travelled within mainland Africa more for business than for holidays (63,5% as opposed to 33,7%) and similarly, they travelled overseas more for holidays than business (65,1% as opposed to 30,2%).

The number of returning South African residents during 2002 was 3 849 790, an increase of 1,2% compared to the 3 802 459 who returned during 2001. The predominant mode of travel used by South Africans in returning to SA was road, 2 623 126 (68,1%), followed by air, 1 219 399 (31,7%).

Of the South African residents returning by air, 1 492 360 (79,2%) entered through Johannesburg International Airport, 369 638 (19,6%) entered through Cape Town International Airport, 11 133 (0,6%) entered through Durban International Airport and the rest, 11 848 (0,6%) entered through other airports.

Leading destination countries for departing South African residents

For South African residents who departed 'temporarily' during 2002, using the three international airports as ports of exit, the leading countries of destination were the following: the UK, 153 736 (21,1%); the USA, 52 218 (7,2%); Namibia, 35 302 (4,8%); Australia, 31 282 (4,3%); Mauritius, 23 851 (3,3%); Germany, 24 090 (3,3%) and Zimbabwe, 18 250 (2,5%).

Figure 12 shows the leading destination countries for SA residents leaving for holiday, while Figure 13 shows leading destination countries for SA residents leaving on business trips during 2002. A little over 34% of all South African residents departing for holiday travelled either to the UK (25,0%) or to the USA (9,8%). This was followed by those travelling to Germany (14,6%), and the Netherlands (6,5). For South African residents leaving on business trips, the leading destination countries were the UK (22,5%), the USA (12,6), Germany (7,6) and Australia (4,2). The four most popular destinations for South African residents leaving on business trips or on holiday, were the UK, the USA, Germany and the Netherlands.

Fig. 1: Arrival and departure of foreign travellers, SA, 1970 - 2002




Fig. 2a: Arrival and departure of South African residents, 1970 - 1989





Fig. 2b: Arrival and departure of South African residents, 1990-2002

Fig. 4: Arrivals: Travellers from Africa by country of residence, 2002







Fig. 5: Arrivals: Overseas visitors by country of residence, 2002




**Fig. 6: Arrivals: Overseas travellers by purpose of visit,

2002**




Fig. 10: Overseas holiday-makers by country of residence, 2002




Fig. 11: Overseas arrivals on business trips by country of residence, 2002




Fig. 12: Leading destinations of South African residents departing for holidays, 2002





Fig. 13: Leading destination of South African residents departing for business, 2002



EXPLANATORY NOTES

1. Background

1.1 Data collection instruments

Legal movements across South African borders, as well as legal immigration into SA, fall under the jurisdiction of the Department of Home Affairs (DHA). Data on tourism are obtained through three main data collection instruments: the arrival form, the departure form and the passport.

With effect from 4 January 1993, a new computerised system for the recording of travellers to and from SA was implemented by the DHA. For South African residents data on temporary departures are obtained from scanning of the bar codes in the passport (upon departure and upon return) and from the departure forms. The filling-in of departure forms used to be done at all ports of entry, but since 26 November 1993 this system is only implemented at the three international airports of Johannesburg, Cape Town and Durban.

For non-South African residents, data on entry into SA for temporary stays are obtained from the arrival form submitted at the port of entry. When non-South African residents first enter SA, bar codes (TRP label) are affixed to their passport. This bar code is subsequently scanned into the computer when the non-South African resident is leaving the country. This facilitates the recording of departure dates from SA and avoids the need for filling in departure forms. Lastly, administrative records are kept for all non-South African residents who have been granted permanent residence status (either before arrival or after arrival).

1.2 Compilation of tourism statistics

For foreign travellers information on their arrivals and departures is obtained from all ports of entry. After the data have been captured at the port of entry, they are sent electronically to the DHA, and loaded unto the mainframe computer at Bureau Nucleus. Statistics South Africa (Stats SA) accesses these data remotely and processes them to produce tourism statistics for foreign travellers. A South African resident who leaves or re-enters South African borders by rail, road, air or sea gets his/her passport scanned to read the bar code. This simple action provides basic particulars about the person. For those passports that do not have a stripe or bar code, the Home Affairs official at the port of entry, captures onto the computer, the personal details reflected on the passport. This information is directly updated on the mainframe computer of the DHA. Information on country of destination and reason for temporary departure of South African residents is obtained from departure forms. The forms are sent to Stats SA on a weekly basis for data capture and processing. It must be noted that the filling

in of the departure forms is not strictly enforced, hence the statistics on the actual number of South African residents who depart temporarily, are obtained from the data based on the scanning of the bar codes in the passports.

For both foreign travellers and South African residents, the information collected on purpose of visit or departure, comes from what has been stated by the traveller. What is stated by the traveller is accepted as correct.

1.3 Shortcomings in tourism statistics

All statistics have their limitations. An important distinction to be noted is that the statistics presented here refer to the number of movements of travellers rather than the number of travellers. Because of multiple movements of travellers, the number of movements is always larger than the number of travellers. In the case of travel by air to and from overseas, the gap between the two statistics tends to be rather narrow, while in the case of travel by road within the Southern African region, the gap tends to widen.

2. Definitions

2.1 Definitions used by the World Travel Organisation (WTO)

2.1.1 **Tourism** comprises the activities of persons travelling to, and staying in places outside their usual environment, for not more than one consecutive year, for leisure, business and other purposes. The usual environment of a person consists of a certain area around his/her place of residence, plus all other places he/she frequently visits.

2.1.2 **Tourist** (overnight visitor) is a visitor who stays at least one night in collective or private accommodation in the place visited. An international tourist is an international visitor who stays at least one night in collective or private accommodation in the country visited. Domestic tourist refers to a domestic visitor who stays at least one night in collective or private accommodation in the place visited.

2.1.3 **International tourist** is an international visitor who stays at least one night in collective or private accommodation in the country visited.

2.1.4 **Domestic tourist** refers to a domestic visitor who stays at least one night in collective or private accommodation in the place visited.

- 2.1.5 **Traveller** refers to any person on a trip between two or more localities.
- 2.1.6 **International travellers** refer to any person on a trip between two or more localities in different countries.
- 2.1.7 **Domestic traveller** refers to any person on a trip between two or more localities in his/her country of residence.
- 2.1.8 **Visitor** refers to any person travelling to a place other than that of his/her usual environment for less than 12 consecutive months and whose main purpose of trip is not the exercise of an activity remunerated from within the place visited.
- 2.1.9 **International visitor** refers to any person travelling to a country other than the one in which he/she has his/her usual residence, but outside his/her usual environment, for less than 12 consecutive months and whose main purpose of trip is not the exercise of an activity remunerated from within the place visited.
- 2.1.8 **Domestic visitor** refers to any person residing in a country, who travels to a place within a country other than the one in which he/she has his/her usual environment, for less than 12 consecutive months, and whose main purpose of trip is not the exercise of an activity remunerated from within the place visited.

2.2 Definitions used specifically in this report

- 2.2.1 **Overseas traveller** refers to a traveller from overseas. It does not include a traveller from mainland Africa, African islands or from an 'unspecified' country.
- 2.2.2 **Foreign traveller** refers to a person who resident outside SA and visit the country temporarily for one or more of the following reasons:
- Business purpose (including official visits) for a duration of less than 90 days;
 - Holiday (including visits to family or friends);
 - Study purpose;
 - Work purpose (for duration of less than 90 days);
 - Contract work;
 - Transit (for persons staying less than 24 hours in the country).
- 2.2.3 **Border traffic concession-** is granted to a person who crosses the border on a frequent basis. This concession is granted for a maximum of six months after which it can be renewed if necessary. No mode of travel is available for border traffic concessions.

- 2.2.4 **South African residents** are persons resident in SA (South African citizens and persons with permanent residence) who leave the country temporarily.
