

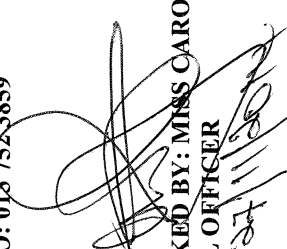
NOTICE 215 OF 2015
