

AMENDMENT OF THE REGULATIONS FOR THE SOUTH AFRICAN POLICE SERVICE

The Minister of Police has, under section 24(1) of the South African Police Service Act, 1995 (Act No. 68 of 1995), made the regulations in the Schedule.

SCHEDULE

1. DEFINITION

In these Regulations, "the Regulations" mean the South African Police Service Employment Regulations, 2008, promulgated by Government Notice R.973 of 12 September 2008.

2. SUBSTITUTION OF REGULATION 11 OF THE REGULATIONS

Regulation 11 of the Regulations is hereby amended by the substitution for regulation 11 of the following regulation:

"In this Part, unless the context indicates otherwise, —

"designated employee" means the National Commissioner or any other employee of the Service;

"Register" means the Register of Designated Employees' Interests kept by the Director-General: Office of the Public Service Commission;

"registrable interests" means the financial interests listed in regulation 13;

"remuneration" means any payment or benefit in cash or in kind; and

"submitted form" means a form submitted by a *designated employee* to the *Minister* in terms of regulation 12 or any copy thereof."

1. WOORDOMSKRYWINGS

In hierdie Regulasies beteken “die Regulasies” die Suid Afrikaanse Polisie diensregulasies, 2008, uitgevaardig deur Goewermentskennisgewing R.973 van 12 September 2008.

2. VERVANGING VAN REGULASIE 11 VAN DIE REGULASIES

Regulasie 11 van die Regulasies word hiermee gewysig deur die vervanging van regulasie 11 met die volgende regulasie:

“In hierdie Deel, tensy uit die samehang anders blyk, beteken —
“aangewese werknemer” die Nasionale Kommissaris of enige ander werknemer van die Diens;
“ingehandigde vorm” ‘n vorm of enige afskrif daarvan, wat ingevolge regulasie 13 deur die *aangewese werknemer* by die *Minister* ingehandig is;
“Register” die Register van die Belange van Aangewese Werknemers wat deur die Direkteur-Generaal: Kantoor van die Staatsdienskommissie bygehou word;
“registreerbare belange” die finansiële belange wat in regulasie 13 gelys is;
 en
“vergoeding” enige betaling of voordeel in kontant of goedere.”
