

## **PROCLAMATION**

*by the*

***President of the Republic of South Africa***

**No. R. 16, 2015**

### **SPECIAL INVESTIGATING UNITS AND SPECIAL TRIBUNALS ACT, 1996 (ACT NO. 74 OF 1996): AMENDMENT OF PROCLAMATION NO. R. 49 OF 2014**

Under section 2(4) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996), I hereby amend Proclamation No. R. 49 of 2014, by—

- (a) the substitution for the first paragraph of the Proclamation of the following paragraph:

“WHEREAS allegations as contemplated in section 2(2) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996) (hereinafter referred to as the “Act”), have been made in respect of the affairs of—

  - (a) the KwaZulu-Natal Provincial Treasury (hereinafter referred to as “the Treasury”);
  - (b) the departments of the KwaZulu-Natal Provincial Government as set out in Schedule 2 to the Public Service Act, 1994 (Proclamation No. 103 of 1994), which received funding from the Treasury in respect of the ‘Commemorating Prisoners of War – St Helena’ event and the Durban International North Sea Jazz Festival (hereinafter referred to as ‘the Departments’); and
  - (c) the KwaZulu-Natal Sharks Board.”;
- (b) the insertion in the second and fourth paragraphs of the Proclamation after the expression “Treasury”, wherever it appears, of the expression “, the Departments and the KwaZulu-Natal Sharks Board”;
- (c) the substitution for paragraph 2 of the Schedule to the Proclamation of the following paragraph:

“2. The validity of funding provided by the Treasury in respect of the—

  - (a) ‘Commemorating Prisoners of War – St Helena’ event;
  - (b) Durban International North Sea Jazz Festival; and
  - (c) KwaZulu-Natal Sharks Board,

and any unauthorised, irregular or fruitless and wasteful expenditure incurred by the Treasury in respect of the provision of such funding.”; and
- (d) the addition of the following paragraph to the Schedule of the Proclamation:

“3. Any unauthorised, irregular or fruitless and wasteful expenditure incurred by the Departments and the KwaZulu-Natal Sharks Board in respect of the funding received from the Treasury contemplated in paragraph 2.”.
