## ACT

To repeal or amend certain laws so as to do away with certain powers to differentiate between persons of different races; and to provide for matters connected therewith.

*(English text signed by the State President.)*  
*(Assented to 28 June 1990.)*

**B**E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

### Repeal and amendment of laws

1. The laws mentioned in the Schedule are hereby repealed or amended as set out  
5 in the third column of the Schedule.

### Short title and commencement

2. This Act shall be called the Discriminatory Legislation regarding Public Amenities Repeal Act, 1990, and shall come into operation on 15 October 1990.
