REGULATION OF FUNCTIONS OF OFFICERS IN THE PUBLIC  
SERVICE ACT, 1980

Act No. 19, 1980

**ACT**

To provide for the administration of the provisions of laws by officers in the public service in the case of a reorganization or readjustment of the functions of departments of State.

*(English text signed by the State President.)  
(Assented to 28 March 1980.)*

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. (1) When in the case of a reorganization or readjustment of the functions of departments of State, the administration of the provisions of any law which are assigned to any Minister of State are assigned to another Minister of State, or the administration of such provisions otherwise necessitates it, the State President may direct that powers, duties or functions which in terms of that law are or may be conferred or imposed upon or assigned to an officer in the public service—
- (a) having a particular official designation, shall or may be conferred or imposed upon or assigned to such an officer having a different official designation;
- (b) attached to a particular department of State, shall or may be conferred or imposed upon or assigned to such an officer in another department of State,
- and may adjust the provisions of any law in order to give effect to such direction.
- (2) The powers conferred by subsection (1) may be exercised with retrospective effect to a date not earlier than 1 March 1980.

Administration of provisions of laws by officers in public service.

2. This Act shall cease to have effect on 1 March 1981.

Duration of this Act.

3. This Act shall be called the Regulation of Functions of Officers in the Public Service Act, 1980.
