ACT

To amend the Roodepoort and Weltevreden Agricultural Settlements Adjustment Act, 1966, so as to regulate the ownership of those portions of the common grazing ground of the Roodepoort Agricultural Settlement which were not divided into lots; and to provide for matters connected therewith.

B^E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Insertion of section 3A in Act 53 of 1966

The following section is hereby inserted in the Roodepoort and Weltevreden
Agricultural Settlements Adjustment Act, 1966 (hereinafter referred to as the principal Act), after section 3:

"Ownership of undivided lots of common grazing ground

3A. (1) The ownership of those portions of the common grazing ground of the Roodepoort Agricultural Settlement which have not been divided into lots, shall vest in the State.

(2) The Minister of Public Works and Land Affairs shall dispose of the portions of the common grazing ground referred to in subsection (1), in terms of the State Land Disposal Act, 1961 (Act No. 48 of 1961).

(3) On production of the title deeds of the land affected the Registrar of Deeds at Bloemfontein shall cause such notes and endorsements to be made in his registers and on the relevant title deeds as may be necessary to give effect to the provisions of this section.".

Substitution of section 5 of Act 53 of 1966

2. The following section is hereby substituted for section 5 of the principal Act:

"No compensation payable in respect of rights vesting in the State under this Act

5. No compensation shall be payable in respect of any rights vesting in the State by virtue of the provisions of section 2 [or], 3A or 4.".
