# ACT

To amend the Credit Agreements Act, 1980, so as to further define certain expressions; and to provide for incidental matters.

> (English text signed by the State President.) (Assented to 9 September 1987.)

**B**E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 75 of 1980, as amended by section 1 of Act 9 of 1985. 1. Section 1 of the Credit Agreements Act, 1980, is hereby amended—

- (a) by the substitution for the definition of "initial pay- 5 ment" of the following definition:
  - "'initial payment' means the amount to be paid by the credit receiver [on the date] in the case of a credit agreement which is a credit transaction;";
- (b) by the substitution for the definition of "initial rental" 10 of the following definition:
  - "'initial rental" means the amount to be paid by the credit receiver **[on the date]** in the case of a credit agreement which is a leasing transaction;"; and

(c) by the substitution for the definition of "Minister" of 15 the following definition:

"'Minister' means the Minister of [Trade and Industry] Economic Affairs and Technology;".

2. This Act shall be called the Credit Agreements Amendment Act, 1987, and shall be deemed to have come into opera-20 tion on 2 March 1981.
