COAL RESOURCES ACT REPEAL ACT, 1992

Act No. 6, 1992

GENERAL EXPLANATORY NOTE:

ACT

To repeal the Coal Resources Act, 1985; to amend the Price Control Act, 1964, so as to delete a reference therein to the first-mentioned Act; and to provide for matters connected therewith.

(English text signed by the State President.) (Assented to 3 March 1992.)

B^E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Repeal of Act 60 of 1985

- 1. The Coal Resources Act, 1985 (Act No. 60 of 1985), is hereby repealed.
- 5 Amendment of section 1 of Act 25 of 1964, as amended by section 1 of Act 80 of 1967, section 1 of Act 39 of 1976 and section 17 of Act 60 of 1985
 - 2. Section 1 of the Price Control Act, 1964 (Act No. 25 of 1964), is hereby amended by the substitution for the definition of "goods" of the following definition:
- " 'goods' includes used goods [but excludes coal as defined in section 1 of the Coal Resources Act, 1985];".

Short title

3. This Act shall be called the Coal Resources Act Repeal Act, 1992.
