STATE OIL FUND AMENDMENT ACT, 1980

GENERAL EXPLANATORY NOTE:

To amend the State Oil Fund Act, 1977, so as to provide that the levy which may be imposed on petroleum products may differ according to the purpose for which such products are used; and to make provision for the exemption from such levy of certain petroleum products manufactured for use outside the Republic; and to provide for incidental matters.

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:-

1. Section 1A of the State Oil Fund Act, 1977, is hereby Amendment of nded—
