"Advances to the South African Bantu TRUST

Advances to

45ter. (1) The bank may, on such conditions as the board may determine, advance money to the Bantu Trust. South African Bantu Trust, established by the Bantu Trust and Land Act, 1936 (Act No. 18 of 1936), to repay any money owing to the bank by a person whose land has been acquired by the said Trust.

- (2) The repayment of any money advanced in terms of subsection (1), and the payment of interest thereon, shall be deemed to be guaranteed by the Government.".
