PRIVATE ACT

To amend Act No. 20 of 1863 (Cape of Good Hope) and the Eastern Province Guardian Loan and Investment Company Amendment, Indemnity and Further Powers (Private) Act, 1920, in respect of the name of the company referred to therein.

> (English text signed by the State President.) (Assented to 30th March, 1972.)

WHEREAS by deed bearing date the seventeenth day of Preamble.

December, 1861, a joint stock company was formed in Grahamstown, in the Colony of the Cape of Good Hope, under the style of the Eastern Province Guardian Loan and Investment Company;

AND WHEREAS the company was incorporated under and by virtue of Act No. 20 of 1863 (Cape of Good Hope);

AND WHEREAS the company's objects and powers were increased by the Eastern Province Guardian Loan and Investment Company Amendment, Indemnity and Further Powers (Private) Act, 1920 (Act No. 25 of 1920);

AND WHEREAS the company has become a wholly owned subsidiary of The Syfret and South African Trust Companies Limited:

AND WHEREAS it is expedient to alter the company's name to **COMPANY** TRUST AND EXECUTOR (GRAHAMSTOWN)" so as to indicate that it is a subsidiary of The Syfret and South African Trust Companies Limited;

RE IT THEREFORE ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:-

1. The company hitherto known as "The Eastern Province Change of name Guardian Loan and Investment Company" and incorporated of company to "Syfrets Trust" "Syfrets with that name by Act No. 20 of 1863 (Cape of Good Hope), "Syfrets Trust as amended by the Eastern Province Guardian Loan and Company Investment Company Amendment, Indemnity and Further (Grahamstown)". Powers (Private) Act, 1920 (Act No. 25 of 1920), shall from the commencement of this Act, be known for all purposes as "Syfrets Trust and Executor Company (Grahamstown)", and any reference in any law (or in any deed instrument or other document referred to in any law) to "The Eastern Province Guardian Loan and Investment Company" shall be deemed to be a reference to "Syfrets Trust and Executor Company (Grahamstown)".

Section 6 of the Eastern Province Guardian Loan and Amendment of Investment Company Amendment, Indemnity and Further section 6 of Powers (Private) Act, 1920, is hereby amended by the substitu- Act 25 of 1920. tion for the words "The Eastern Province Guardian Loan and Investment Company" of the words "Syfrets Trust and Executor Company (Grahamstown)".
