COLOURED PERSONS EDUCATION AMENDMENT ACT, 1976 Act No. 29, 1976

To amend the Coloured Persons Education Act, 1963, so as to provide for the establishment of primary, junior secondary and senior secondary schools; and to provide for incidental matters.

RE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as

1. Section 1 (1) of the Coloured Persons Education Act, 1963, Amendment of reby amended—

(a) by the deletion of the definitions of "high school" and as amended by is hereby amended-

by the insertion after the definition of "home" of the Act 76 of 1967

following definition:
"'junior secondary school' means a school for the education of Coloured persons up to and including the seventh standard;

(c) by the substitution for the definition of "primary school" of the following definition:
"'primary school' means a school for the education

of Coloured persons up to and including the fifth standard;"; and

(d) by the insertion after the definition of "Secretary"

of the following definition:
"'senior secondary school' means a school for the education of Coloured persons up to and including the tenth standard;".

2. Section 3 of the Coloured Persons Education Act, 1963, Amendment of is hereby amended by the substitution for paragraph (a) of section 3 of Act 47 of 1963.

subsection (1) of the following paragraph:

"(a) establish, erect and maintain training-colleges, training-schools, senior secondary schools, junior secondary schools, primary schools, agricultural schools, vocational schools, special schools and homes;".

3. This Act shall be called the Coloured Persons Education Short title and Amendment Act, 1976, and shall be deemed to have come into commencement. operation on 1 January 1976.
