DAIRY INDUSTRY LAWS AMENDMENT ACT, 1972.

To amend the provisions of the Dairy Industry Act, 1961, so as to apply it to the territory of South-West Africa in so far as it relates to margarine; to amend the provisions of the Dairy Industry Control Ordinance, 1962, of the territory of South-West Africa, in so far as it relates to margarine; and to provide for incidental matters.

(English text signed by the State President.) (Assented to 4th May, 1972.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:-

1. Section 1 of the Dairy Industry Act, 1961 (hereinafter Amendment of section 1 of Act 30 of 1961, referred to as the principal Act), is hereby amended-

- (a) by the substitution for the definition of "board" of as amended by the following definition: Act 34 of 1965
 - "'board', in relation to the manufacture of margarine and section 1 of Act 96 of 1971. in the territory, means the Dairy Industry Control Board established by the Dairy Industry Control Ordinance, 1962 (Ordinance No. 29 of 1962), of the territory, and, in relation to any other matter, means the Dairy Board established by Proclamation No. R.25 of 1972;";
- (b) by the insertion after the definition of "regulation" of the following definition:
 - "'Republic', in relation to margarine, includes the territory;";
- (c) by the insertion after the definition of "sterilised milk plant" of the following definition:
 - "territory' means the territory of South-West Africa, including the Eastern Caprivi Zipfel;".

2. Section 4 of the principal Act is hereby amended by the Amendment of substitution for subsection (2) of the following subsection:

"(2) If the Minister is satisfied that the requirements of as amended by (2) If the Minister is satisfied that the requirements of section 1 of this Act and of the Factories, Machinery and Building Act 1 of 1969. Work Act, 1941 (Act No. 22 of 1941), or, in relation to the territory, the Factories, Machinery and Building Works Ordinance, 1952 (Ordinance No. 34 of 1952), of the territory, in respect of any such premises have been complied with, he shall, subject to the provisions of subsection (3) and of section 6, cause a certificate of registration to be issued to the applicant.".

"(xxviii) 'dairy produce substitute' means any substance which, irrespective of whether or not any dairy product was used in its production, processing or manufacture, is made from animal or vegetable fats or oils or a mixture thereof in imitation, form or semblance of a dairy product, but does not include margarine; (cvii)".
