GENERAL EXPLANATORY NOTE:

ACT

To amend the Animals Protection Act, 1962, so as to empower the Minister of Justice to make regulations relating to the seizure and disposal or destruction of animals; and to provide for matters connected therewith.

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

1. Section 10 of the Animals Protection Act, 1962, is hereby amended by the substitution for paragraph (c) of subsection (1) of the following paragraph:

"(c) the seizure, impounding, custody or confining of any animal due to any condition of such animal, the discontinuous confining of such animals.
