SECOND RAILWAYS AND HARBOURS ACTS AMENDMENT Act No. 89, 1976 ACT, 1976

To amend section 1 of the Railways and Harbours Pensions Amendment Act, 1941, and section 1 of the Railways and Harbours Pensions for Non-Whites Act, 1974, so as to insert a new definition "Republic of South Africa", and to provide for matters incidental thereto.
