ACT

To amend the State Land Disposal Act, 1961, so as to grant to a member of a Ministers' Council certain powers in respect of certain State land.

(Afrikaans text signed by the State President.) (Assented to 14 March 1988.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

1. Section 1 of the State Land Disposal Act, 1961, is hereby amended by the substitution for the definition of "Minister" of Act 48 of 1961, as substituted by

"'Minister' means the Minister of Public Works and Land

Affairs, but in relation to—
