To amend the National Supplies Procurement Act, 1970, so as to alter the designations of the responsible Minister and Director-General; and to make further provision in connection with the power of the Minister to prohibit the disclosure of certain information; and to provide for matters connected therewith.

E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 89 of 1970, as amended by section 1 of Act 89 of 1974 and section 1 of Act 31 of 1982

1. Section 1 of the National Supplies Procurement Act, 1970 (hereinafter referred to as the principal Act), is hereby amended by the substitution for the definition of "Minister" of the following definition:

"'Minister' means the Minister of [Industries, Commerce and Tourism] Economic Affairs and Technology;".

10 Amendment of section 1A of Act 89 of 1970, as inserted by section 2 of Act 31 of 1982

2. Section 1A of the principal Act is hereby amended by the substitution for the expression "Minister of Industries, Commerce and Tourism" wherever it occurs of the expression "Minister of Economic Affairs and Technology".

Amendment of section 8B of Act 89 of 1970, as inserted by section 1 of Act 73 of 1979

- 3. Section 8B of the principal Act is hereby amended— 15
 - (a) by the substitution for subsection (1) of the following subsection:
 - "(1) Whenever the Minister deems it necessary or expedient [for the security of the Republic in the public interest, he may by notice in the Gazette, or by written notice to a particular person or particular persons, prohibit the disclosure of any information in relation to any goods or service, or of any statement, comment or rumour calculated directly or indirectly to convey such information."; and
 - (b) by the addition of the following subsection:
 - "(3) If a South African citizen or a person domiciled in the Republic has contravened a prohibition referred to in subsection (1) outside the Republic

it shall be deemed that he has contravened the prohibition at the place in the Republic where he is brought before the court.".

Amendment of section 12 of Act 89 of 1970, as amended by section 19 of Act 63 of 1973 and section 3 of Act 31 of 1982

- 5 4. Section 12 of the principal Act is hereby amended by the substitution in subsection (2) for the words preceding paragraph (a) of the following words:
 - "The Director-General: [Industries, Commerce and Tourism] Trade and Industry, shall, subject to the provisions of this Act, be responsible for the administration of the fund and in particular for—".
- 10 Amendment of section 18 of Act 89 of 1970, as substituted by section 5 of Act 31 of 1982
 - 5. Section 18 of the principal Act is hereby amended by the substitution for paragraph (b) of subsection (1) of the following paragraph:
- "(b) the Minister of [Industries, Commerce and Tourism] Economic Affairs and Technology under the Import and Export Control Act, 1963 (Act No. 45 of 1963);".

Short title

6. This Act shall be called the National Supplies Procurement Amendment Act, 1988.
