# ACT

To amend the Temporary Removal of Restrictions on Economic Activities Act, 1986, so as to make provision for the duration of the Act until 31 March 1994.

*(Afrikaans text signed by the State President.)*  
*(Assented to 17 June 1988.)*

**B**E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

**Amendment of section 4 of Act 87 of 1986**

1. Section 4 of the Temporary Removal of Restrictions on Economic Activities Act, 1986, is hereby amended by the substitution for subsection (1) of the following subsection:

“(1) This Act shall cease to have effect on 31 March **[1989]** 1994.”.

**Short title**

2. This Act shall be called the Temporary Removal of Restrictions on Economic Activities Amendment Act, 1988.
