

NOTICE 665 OF 2015**NOTICE TO LODGE LAND CLAIMS ON CERTAIN PROPERTIES IN THE MARULENG DISTRICT OF LIMPOPO PROVINCE**

Take notice that the Chief Land Claims Commissioner has decided in terms of section 12(4) of the Restitution of Land Rights Act No 22 of 1994 as amended ("the Restitution Act"), that the resources of the Commission on Restitution of Land Rights ("the Commission") and the Land Claims Court will be more effectively utilised if all claims for restitution of rights in land in terms of the Act in respect of the area represented by the properties listed in the schedule below ("the area") were to be investigated at the same time.

The Chief Land Claims Commissioner accordingly invites all persons who wish to lodge land claims in terms of section 10 of the Restitution Act in respect of any land in the area to do so **by no later than 31 December 2015**. If any claim is lodged in response to this notice, the claimant is requested to alert the official receiving the claim that it is lodged in response to this notice.

Persons or communities may lodge claims if they comply with section 2 of the Restitution Act. Claims are lodged in person through an electronic system. Claimants who wish to lodge land claims in respect of the properties listed in the schedule must lodge them at the offices of the Department of Rural Development and Land Reform in Mbombela or Polokwane. The addresses of the Department of Rural Development and Land Reform are: 30 Samora Machel Drive, Mbombela for attention of Mr ES Nkosi and 61 Biccard Street, Polokwane for attention of Mr Tele Maphoto.

No claim for restoration of rights in land shall be lodged after **31 December 2015** provided that the Commission may allow a claimant, on good cause shown, to lodge a land claim after the expiry of such a period, but not later than 30 June 2019.
