The Information Officer may delete any part of a record contemplated in (1)(a) (Subsection (1)(a) of Section 15 of the ACT above, which on a request for access, may or must be refused in terms of Chapter 4 of this Part. In terms of Section 15, subsection (5) of the Act, "section 11 and any other provisions in this Act related to that section do not apply to any category of records included in a notice in terms of subsection (2)". Section 11 deals with the "Right of access to records of public bodies."
