SMALL CLAIMS COURTS ACT, 1984 (ACT NO. 61 OF 1984)

ESTABLISHMENT OF SMALL CLAIMS COURTS FOR THE AREAS OF THE LIMPOPO PROVINCE AND MPUMALANGA PROVINCE

 John Harold Jeffery, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Correctional Services, hereby, with effect from 25 January 2016—

- (a) in terms of section 2(1)(e) of the Small Claims Courts Act, 1984 (Act No. 61 of 1984),
 withdraw the Government Notices mentioned in Column A of the Schedule;
- (b) in terms of section 2(1)(a) of the said Act, establish the small claims courts mentioned in Column B of the Schedule for the areas mentioned in Column C of the Schedule;
- (c) in terms of section 2(1)(aA) of the said Act, determine the seats of such small claims courts, established in terms of paragraph (b), as is mentioned opposite thereto in Column D of the Schedule, and
- (d) in terms of section 2(1)(b) of the said Act, determine the places in the areas concerned for the holding of sessions of the courts established in terms of paragraph (b) as mentioned opposite thereto in Column E of the Schedule.

Despite the withdrawal of the Government Notices mentioned in Column A of the Schedule, any claim which has already been instituted in a small claims court which has jurisdiction to adjudicate the matter, shall be continued and concluded as if this Government Notice has not been published.
