I, Gugile Ernest Nkwinti, Minister for Department of Rural Development and Land Reform, hereby establish the office of the Surveyor-General: North West on the date of publication of this notice in terms section 4 of the Land Survey Act, 1997 (Act 8 of 1997), by amending Notices 1314, 561 and 494 published in Government Gazettes No.19049, 32233 and No.35463 on 17 July 1998, 22 May 2009 and 29 June 2012 respectively, as follows:

- (a) by substituting the entire row and its content as depicted in item 1 of the items set out in Schedule 1;
- (b) by establishing the office of the Surveyor-General: North West with its jurisdiction in North West Province as set out in item 1 of Schedule 2; and
- (c) by simultaneous renaming of the office of the Surveyor-General: Pretoria to office of the Surveyor-General: Gauteng and redefining its jurisdiction area from Gauteng and North West as set out in item 1 of Schedule 1 to Gauteng as set out in item 2 of Schedule 2.
