CALL FOR WRITTEN SUBMISSIONS FROM STAKEHOLDER BODIES AND MEMBERS OF THE PUBLIC TO REPEAL THE PROVISO ON THE COMPULSORY OFFERING OF ACCOUNTING WITH MATHEMATICS

1. I, Angelina Matsie Motshekga, Minister of Basic Education, hereby, in terms of *section 3(4)(l)* of the *National Education Policy Act, 1996 (Act No. 27 of 1996)*, give my intention to amend the following policy document:
 - (a) *National Policy pertaining to the Programme and Promotion Requirements of the National Curriculum Statement Grades R–12*, promulgated as *Government Notices No. 1115 and 1116 in Government Gazette No. 36042 of 28 December*.

DEFINITIONS

1. In this policy, "policy" means the policy published as *Government Notices No. 1115 and 1116 in Government Gazette No. 36042 of 28 December 2012 as amended as-*

Government Notices 499 and 500 in Government Gazette, No. 36465 dated 17 May 2013;

Government Notice 564 in Government Gazette, No. 37840 dated 18 July 2014;

Government Notices 625 and 626 in Government Gazette, No. 37910 dated 13 August 2014;

Government Notices 236 and 237 in Government Gazette, No. 38590 dated 20 March 2015;

Government Notices No. 1160 and 1161 in Government Gazette, Vol.605, No. 39435 dated 20 November 2015.

Government Notices No.1496 and 1497 in Government Gazette, No. 40472 dated 2 December 2016.

Paragraph 28(4D): PROVISOS is hereby amended by –

1. Learners offering Physical Sciences [and Accounting] as one [or more] of their optional subjects selected from Group B in the policy document, *National policy Pertaining to the Programme and Promotion Requirements of the National Curriculum Statement Grades R – 12*; must offer Mathematics as a compulsory subject selected from Group A in the said policy document.
