**APPLICATION FOR AMENDMENT OF INDIVIDUAL BROADCASTING SPECTRUM
LICENCE BY CAPE TOWN RADIO (PTY) LTD – SMILE 90.4 FM**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from Cape Town Radio, for an amendment of its Individual Broadcasting Spectrum Licence lodged in terms of the provision of section 31(4) of the Electronic Communications Act, No. 36 of 2005 ("ECA") read with procedures set out in Regulation 9 of the Authority's Radio Spectrum Regulations, Notice 279 of 2015 as published in Government Gazette No. 38641 as amended by Government Gazettes No. 38754 of 2015 and 40436 of 2016 ("RFSR2015").
2. Cape Town Radio seeks approval from the Authority to amend its Individual Broadcasting Spectrum Licence to:
 - 2.1 increase the coverage area from City of Cape Town Metropolitan to Western Cape Province; and
 - 2.2 include the following sites to its Individual Broadcasting Spectrum Licence as shown in table 1.

6. All written representations submitted to the Authority in response to this notice shall be made available for inspection by interested persons at the ICASA Library or website and copies of such representations and documents will be obtained upon payment of a fee.

Cape Town Radio shall be entitled to respond in writing to written representations made by interested persons on the amendment application, and such written response must be lodged with the Authority within twenty-one (21) working days of the date of publication of this notice in the Government Gazette.

Cape Town Radio must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand **OR** has sent a copy of such response by registered mail **OR** by fax to the relevant person(s) having made such written representations.
