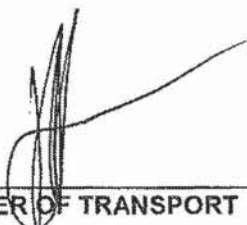

DECLARATION AMENDMENT OF NATIONAL ROAD R510 SECTION 1.**AMENDMENT OF DECLARATION No. 784 OF 2012.**

By virtue of section 40(1)(b) of the South African National Roads Agency Limited and the National Roads Act, 1998 (Act No. 7 of 1998), I hereby amend Declaration No. 784 of 2012 by substituting paragraph N of the Schedule, being the descriptive declaration of the route from a point south of the general boundary between the farms Reinkoyalskraal 278-JQ and Vlakfontein 276-JQ, North of Rustenburg up to the North West/Limpopo Provincial Border, at time of declaration, with the accompanying sheets 1 to 16 of Plan No. P927/17.
