**NOTICE OF AMENDMENT IN TERMS OF SECTION 11 A (4) OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED**

Notice is hereby given in terms of section 11 A (4) of the Restitution of Land Rights Act, 1994 (Act No. 22 of 1994) as amended, that an amendment is hereby made to gazette No: 26540 notice No: 1275 of 2004 to separate Rammalo family land claim and Mushwana family land claim. The land claims have been lodged separately as family claims and should be separated and gazetted as such. Mr. Nicasane James Mushwana lodged a land claim on the 05 June 1996 on behalf of Mushwana family and Mr. Evens Mankweni Rammalo lodged a land claim on the 31 December 1998 on behalf of Rammalo family. The amendment also includes the correct extent claimed by each family since survey was conducted for each family. The claimants/ property information are outlined in the table below:
