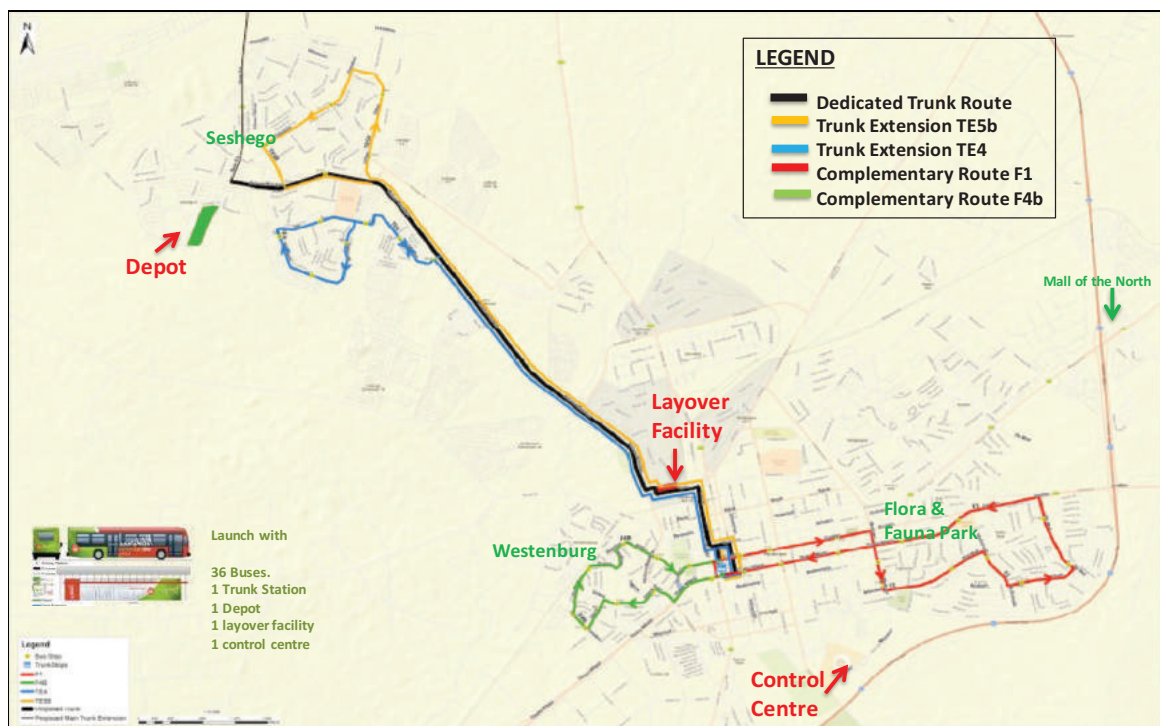

CITY OF POLOKWANE

PROPOSED DETERMINATION OF LEETO LA POLOKWANE PHASE1A ROUTES FOR THE ALIGNMENT FROM CBD TO SESHEGO, WESTERNBURG AND FLORA PARK AS WELL AS THE DETERMINATION OF 1 (ONE) FIXED MEDIAN STATION POSITION AND KERB SIDE STOPS.

Notice is hereby given, in terms of section 65*bis* (2) of the Local Government Ordinance 17 of 1939, read with sections 21 and 21A of the Local Government: Municipal Systems Act 32 of 2000 that the City of Polokwane intends to:

- Determine the **Dedicated Trunk Route** from CBD to Seshego along Nelson Mandela Drive with one (1) Median Station
- Determine the **Trunk Extension Route TE 5B** from CBD to Seshego Zone 2 with six (8) kerb side stops.
- Determine the **Trunk Extension Route TE 4** from CBD to Seshego Zone 1 along with thirteen (9) kerb side stops.
- Determine the **Complementary Route F1** from CBD to Flora Park with six (16) kerb side stops.
- Determine the **Complementary Route F4b** from CBD to Westernburg to CBD along with twenty (9) kerb side stops.



Leeto La Polokwane Trunk Route:

In terms of the dedicated Trunk Route the service will start from the CDB Station situated on General Joubert Street (between Thabo Mbeki and Grobler Street). It will then proceed along General Joubert, turn left onto Jorissen Street and right onto Church Street all the way to Hospital Street all the way via Nelson Mandela into Seshego. In Seshego, the service will proceed from Nelson Mandela Trunk into Trunk Extensions TE4 and TE5B in mixed traffic and back to the CBD. In terms stations and bus stops, there is one (1) median station situated on General Joubert Street (between Thabo Mbeki and Grobler Street), as well as kerbside stops along Landdros Mare, Jorissen, and Church Streets. The locations of the kerb side stops are described in Table 1.

Trunk Extension TE 5B

As far as TE4 is concerned, the service will turn right from Nelson Mandela Drive dedicated trunk onto Ditlou Street past the Seshego Mall on the right. It will then proceed along Ditlou Street, turns left onto Khensani Street, turn left again onto Freedom Drive, turn left again onto Oliver Thambo Drive before turning left back onto Nelson Mandela Street towards the CBD. Towards the CBD, the service proceeds along Nelson Mandela Drive on dedicated trunk lanes, turn left onto Fluorspar Street, turns right onto Silicon Street over the road-over-rail bridge, turn right onto Church Street and proceeds all the way before turning left onto Jorissen Street past General Joubert and Market Streets and turns right onto Landdros Mare Street. Along Landros Mare, the service will proceed all the way and turn right onto Thabo Mbeki Street back to the station on General Joubert Street. From here the service proceeds as explained under the Trunk. Apart from the main station in the CBD which is in the middle of the road, all the other bus stops are on the kerb side. Their locations along the route are as described in Table 2.

Trunk Extension TE4:

As far as TE4 is concerned, the service will turn left from the Nelson Mandela Drive dedicated trunk into Seshego Zone 1 and run along Madiba Park Street, turn Left into Bo-okelo Street, turn right into 9th Street (which becomes Madiba Street) and back onto Nelson Mandela Street towards the CBD. Towards the CBD, the service proceeds along Nelson Mandela Drive on dedicated trunk lanes, turn left onto Fluorspar Street, turns right onto Silicon Street over the road-over-rail bridge, turn right onto Church Street and proceeds all the way before turning left onto Jorrisen Street past General Joubert and Market Streets and turns right onto Landdros Mare Street. Along Landdros Mare, the service will proceed all the way and turn right onto Thabo Mbeki Street back to the station on General Joubert Street. From here the service proceeds as explained under the Trunk. Apart from the main station in the CBD which is in the middle of the road, all the other bus stops are on the kerb side. Their locations along the route are as described in Table 3.

Complementary Route F1

The Service for the Complementary Route F1 will begin at the Station in General Joubert Street, turning right onto Thabo Mbeki Street and right again onto Church Street, turn right onto Grobler Street all the way before turning right onto Webster Street. On Webster, the service will proceed, turn left onto Marshall Street, turn right onto McDonald Street, turn Left onto Boshoff Street, then turn De Wet Street. From Dewet Street the service will connect to Grobler which becomes Thabo Mbeki Street moving back towards the CBD leaving Savannah Mall on the left. The service will proceed along Thabo Mbeki to turn right onto Church Street, right onto Grobler Street before turning right onto General Joubert Street and terminating onto the Station. Apart from the main station in the CBD which is in the middle of the road, all the other bus stops are on the kerb side. Their locations along the route are as described in Table 4.

Complementary Route F4b:

The Service for the Complementary Route F4b begins at the Station in General Joubert Street, it turns Right onto Thabo Mbeki Street until the roundabout. At the roundabout, the service turns right onto Nelson Mandela Drive, it turns left onto Suez Street, left onto Orient Street and left onto Tabriz Street right up to the T-Junction. At the T-junction the service will turn right onto Lawton Street which later becomes Burma Street, turn left into Swallow Street and turn right into Sapphire Street before turning right onto Nikkel Street. From nickel street it will connect to R101 which becomes Globler getting into the CBD. Along Grobler street, the service will turn right onto General Joubert Street and terminating onto the Station. Apart from the main station in the CBD which is in the middle of the road, all the other bus stops are on the kerb side. Their locations along the route are as described in Table 5

All objections and presentations received shall be considered to establish the validity thereof as well as any reasonable mitigating factors that may be introduced to address the objections and presentations received where after the unresolved objections and presentation shall be referred to the Municipality for a final decision. Should no objections be received, the City shall be entitled to proceed with the implementation of the proposed route, stations and stopping places 03 October 2018.
