APPLICATION FOR THE RENEWAL OF INDIVIDUAL COMMERCIAL SOUND BROADCASTING SERVICE AND RADIO FREQUENCY SPECTRUM LICENCES

The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received three applications to renew Individual Commercial Sound Broadcasting Services and Radio Frequency Spectrum Licences lodged in terms of Regulation 10 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 together with Amendment Individual Processes and Procedures Regulations 2015 read together with section 11 of the Electronic Communications Act No. 36 of 2005 ("EC Act"). All Applicants shall be entitled to respond in writing to written representations made by interested persons on the renewal applications, and such written responses must be lodged with the Authority within twenty-one (21) working days from the date of publication of this notice in the *Government Gazette*. Applicants must, at the time of lodging such written responses, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by email to the relevant person having made such written representations.
