PROCLAMATION NO. R. 10 OF 2019

PRESIDENT of the REPUBLIC of SOUTH AFRICA

SPECIAL INVESTIGATING UNITS AND SPECIAL TRIBUNALS ACT, 1996 (ACT NO. 74 OF 1996): APPOINTMENT OF TRIBUNAL PRESIDENT AND ADDITIONAL MEMBERS OF THE SPECIAL TRIBUNAL

1. I hereby, after consultation with the Chief Justice of South Africa—
- (a) in terms of section 7(2) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996) (hereinafter referred to as "the Act"), appoint Judge Gidfonia Mlindelwa Makhanya, as Tribunal President for a period of three (3) years; and
- (b) in terms of section 7(3)(a) of the Act, appoint—
- (i) Judge Kantharuby Pillay;
 - (ii) Judge Johannes Eksteen;
 - (iii) Judge Selewe Peter Mothle;
 - (iv) Judge Lebogang Modiba;
 - (v) Judge Thina Siwendu,
 - (vi) Judge David van Zyl; and
 - (vii) Judge Sirajudien Desai,
- as additional members, of the Special Tribunal established by Proclamation No. R. 118 of 31 July 2001.

2. Proclamation No. R. 75 of 25 October 2002 is hereby withdrawn.
