**DECLARATION AMENDMENT OF NATIONAL ROAD N1 SECTION 25X AND DECLARATION OF
EXISTING ROAD THROUGH THE TOWN OF MOKOPANE AS PART OF NATIONAL ROAD N1
SECTION 25X.**

- i) By virtue of section 40(1)(b) of the South African National Roads Agency Limited and the National Roads Act 1998 (Act No. 7 of 1998), I hereby amend both (I) Declaration No. 1118 of 2007 and (II) Declaration No. 735 of 2016 in entirety, by substituting it with the accompanying sheets 1 to 20 of Plan No. P1074/18.
- ii) By virtue of Section 40 (1)(a) of The South African National Road Agency Limited and National Roads Act 1998 (Act No. 7 of 1998), I hereby declare the section of the road in Mokopane, commencing from points L230 and R262 on sheet 13 of Plan No. P1074/18, and from where it follows the street known as Thabo Mbeki Drive at time of declaration, in a general north easterly direction, up to its junction with the street know as Nelson Mandela Drive at time of declaration, as a National Road.

In the town of Mookgopong the N1 Section 25X enters the town from the South West and follows the street known as Thabo Mbeki street at the time of declaration.

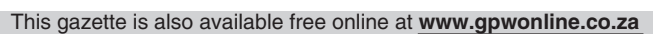

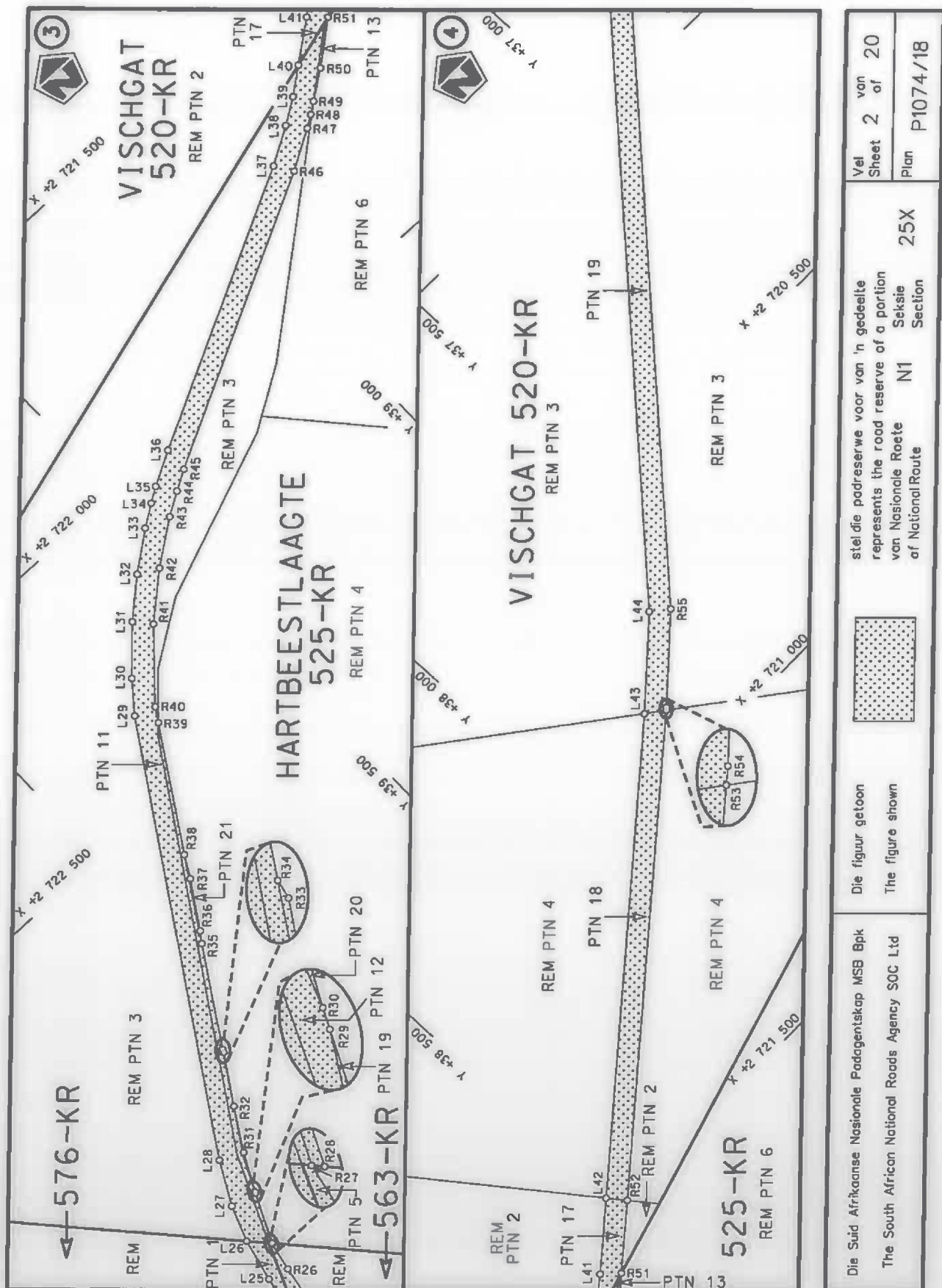

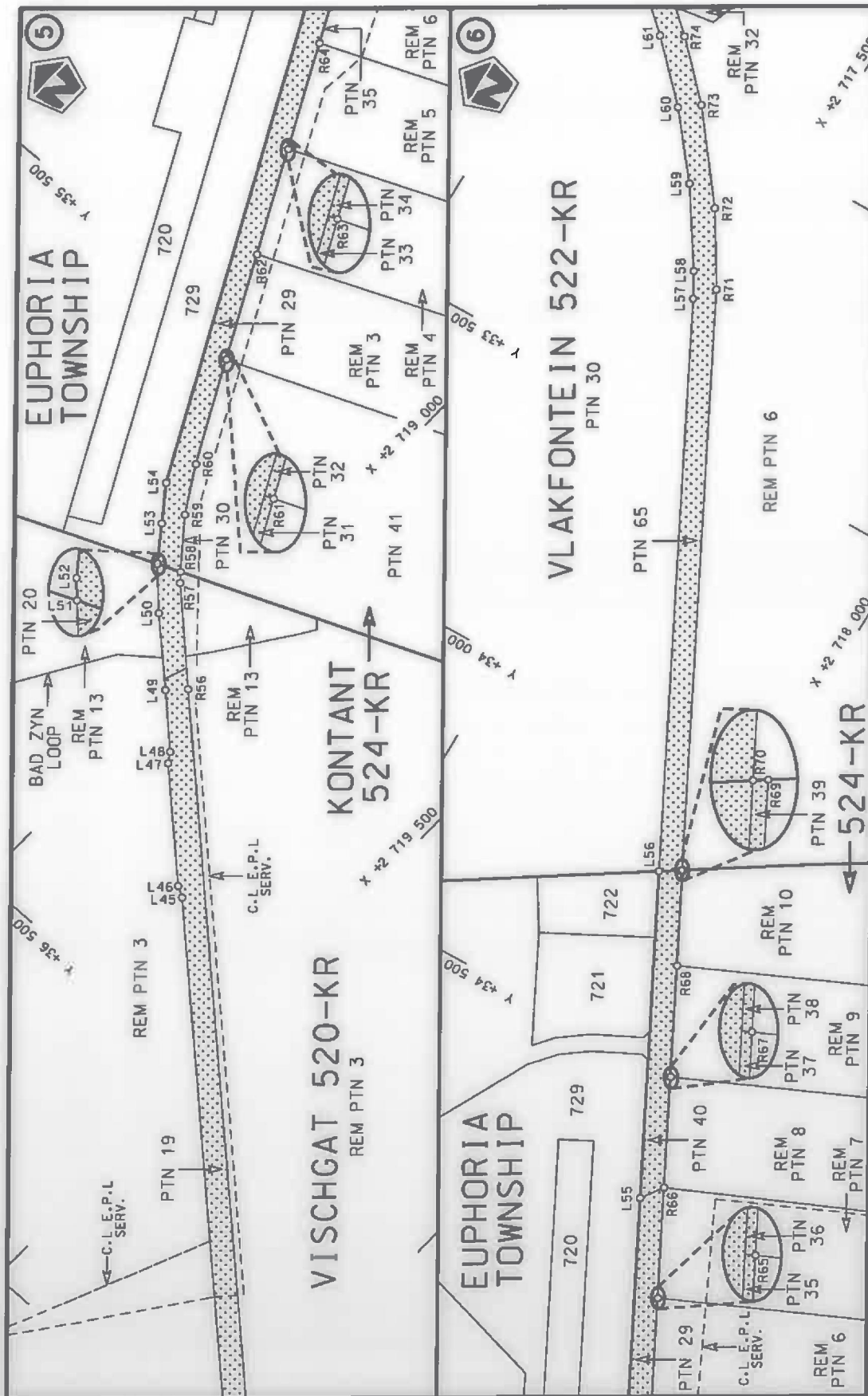
