Small, Medium and Micro Enterprises (SMME), Black Economic Empowerment (BEE) and Developmental needs; Legal with a focus on Negotiation and Contract Management; IT expert- IT Security with Intelligence or Forensic Investigation background; Information and Communications Technology (ICT); e-Government; Strategic Technology Trends; Procurement with integrity; Negotiation and Contract Management; Human Resources

Management; Financial Management, Management Accounting; Financial Reporting; and Auditing; IT systems; networks; programs and IT Governance.
