Nature of offence:

Guilty of contravention of section 27(1) and (2) of the Dental Technicians Act No. 19 of 1979

Penalty:

Mr. Govindsamy's practice as a Dental Technologist, including the performing of acts pertaining to the profession of Dental Technology is suspended for a period of 10 years, nine years of which is suspended for a period of five (5) years on condition that he is not found guilty of the same offence during that period. Should he be found guilty of the same improper or disgraceful conduct during the period of suspension which is five (5) years, the full ten (10) year period of suspension will become effective.

Penalty:

A fine of R 10 000, R 8 000 of which was suspended for a period of three years on condition that the accused is not found guilty of the same offence during that period. R 2,000.00 will be payable within fourteen days after the publication in the government gazette.
