**DRAFT PUBLIC ADMINISTRATION MANAGEMENT REGULATIONS ON CONDUCTING BUSINESS WITH THE STATE, THE DISCLOSURE OF FINANCIAL INTEREST AND ETHICS, INTEGRITY AND DISCIPLINE TECHNICAL ASSISTANCE UNIT, 2019 AND THE OFFICE OF STANDARDS AND COMPLIANCE, 2019**
