## GENERAL NOTICE IN TERMS OF SECTION 11 (A) (2) OF THE RESTITUTION OF LAND RIGHTS ACT, NO 22 OF 1994

WHEREAS a land claim was lodged by Zacharia M. Ndwandwe and Simangele B. Ndwandwe of behalf of the Ndwandwe Family, which claim was published in terms of Section 11 (1) of the Restitution of Land Rights Act, No. 22 of 1994 (as amended), herein referred to as the Act.

AND

WHEREAS during further investigation of the land claim in so far as it related to the properties referred to below, the Regional Land Claims Commissioner, has reason to believe that the criteria set out in paragraph (a) (b) and (c) of Section 11 (1) have been met.

**NOW THEREFORE NOTICE** is hereby given in terms of section 11(A) (2) of the Act that at the expiry of **thirty (30) days** from the date of the publication of this notice in the Government Gazette, the notice of the claim previously published under the terms of section 11 (1) of the Act under Notice No. 472 of 2020 published in Government Gazette No. 43686 dated 4 September 2020, will be amended to **INCLUDE** the property listed below, unless cause to the contrary is shown to the satisfaction of the Regional Land Claims Commissioner.
