**SCHEDULE****DEFINING OF PRODUCTION AREA: CANGO VALLEY**

That portion of land situated within the following boundaries:

Start at a point where the eastern boundary of quartanary catchment area J35A intersects the south-western boundary of Vergeleegen 52/4; thence generally west with the south-western boundary of said Vergeleegen 52/4 and Vergeleegen 54/2 to the south-eastern beacon of farm 85/3; thence further generally west with the southern boundaries of said farm 85/3 and Remainder 248; the south-eastern boundaries of farms 88/14, 88/12, 88/11, 88/10, 88/9, 88/8, 88/7, 88/6 and 88/5; the south-western boundaries of farms 88/23 and 88/24 to the south-western beacon thereof; thence generally north with the western boundaries of said farm 88/24, farms 88/26, 88/27 and 88/14 to a point where the western boundary of quartanary catchment area J35A intersects last-mentioned farm boundary; thence generally north, generally east and generally south with the western, northern and eastern boundaries of said quartanary catchment area J35A to a point where the eastern boundary of said quartanary catchment area J35A intersects the south-western boundary of Vergeleegen 52/4, the point of beginning mentioned above.

Begin by 'n punt waar die oostelike grens van kwartêre opvanggebied J35A die suidwestelike grens van Vergeleegen 52/4 kruis; daarvandaan algemeen wes met die suidwestelike grens van genoemde Vergeleegen 52/4 en Vergeleegen 54/2 tot by die suidoostelike baken van plaas 85/3; daarvandaan verder algemeen wes met die suidelike grense van genoemde plaas 85/3 en Restant 248, die suidoostelike grense van plase 88/14, 88/12, 88/11, 88/10, 88/9, 88/8, 88/7, 88/6 en 88/5, die suidwestelike grense van die plase 88/23 en 88/24 tot by die suidwestelike baken daarvan; daarvandaan algemeen noord met die westelike grense van genoemde plaas 88/24, plase 88/26, 88/27, 88/28 en 88/14 tot by 'n punt waar die westelike grens van kwartêre opvanggebied J35A die laasgenoemde plaasgrens kruis; daarvandaan algemeen noord, algemeen oos en algemeen suid met die westelike, noordelike en oostelike grense van genoemde kwartêre opvanggebied J35A tot by 'n punt waar die oostelike grens van genoemde kwartêre opvanggebied J35A die suidwestelike grens van Vergeleegen 52/4 kruis, die beginpunt hierbo genoem.
