GENERAL NOTICE IN TERMS OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED

Notice is hereby given in terms of Section 11 (1) of the Restitution of Land Rights Act, Act No. 22 of 1994 as amended that a land claim has been lodged by Mr. Matome Piet Modiba on behalf of the Modiba Community before the cut-off date of lodgment of claims on a number of farms situated in Greater Tzaneen Local Municipality within Mopani District Municipality of Limpopo, Province.
