

BOARD NOTICE 181 OF 2021
NOTICE OF APPLICATION FOR THE DEFINING OF A PRODUCTION AREA
PIKET-BO-BERG (WARD)

(In terms of Section 6 of the Wine of Origin Scheme published by Government Notice No. R.1434 of 29 June 1990)

Please take note that Platteklip Vineyards (Pty) Ltd applied to the Wine and Spirit Board to define Piket-Bo-Berg (Ward) as a production area to produce Wine of Origin.

The agricultural region known as Piket-Bo-Berg is located on top of Piketberg Mountain and can only be accessed via the Versveld Pass. The proposed ward falls within the heart of the existing Swartland District and is located in the Coastal Region. The description of the ward is mainly aimed at including areas located higher than the 500 m contour. It can therefore be classified as a high-lying area with a considerably cooler climate and largely different vegetation than that of the lower lying Swartland areas around the mountain. The predominant Table Mountain sandstone geology on top of Piketberg Mountain is also vastly different to the rest of the Swartland, which is mainly comprised of Malmesbury shale.

KENNISGEWING VAN AANSOEK VIR DIE OMSKRYWING VAN PRODUKSIEGEBIED
PIKET-BO-BERG (WYK)

(Ingevolge Artikel 6 van die Wyn van Oorsprong-skema gepubliseer by Goewermements-kennisgewing No. R.1434 van 29 Junie 1990)

Neem kennis dat Platteklip Vineyards (Pty) Ltd by die Wyn- en Spiritusraad aansoek gedoen het vir die afbakening van die produksiegebied Piket-Bo-Berg (Wyk) om Wyn van Oorsprong te produseer.

Die landbougebied, bekend as Piket-Bo-Berg, is geleë bo-op Piketberg en toegang daartoe is uitsluitlik *via* die Versveldpas. Die voorgestelde wyk val in die hart van die bestaande Swartland-Distrik en is geleë in die Kusstreek. Die omskrywing van die wyk is hoofsaaklik daarop gemik om areas hoër as die 500 m-kontoer in te sluit. Dit is dus 'n hoogliggende area waarvan die klimaat aansienlik koeler en die plantegroei grootliks verskillend is as dié van die laerliggende Swartland-areas om die berg. Die oorwegend Tafelberg Sandsteen-geologie bo-op Piketberg verskil ook drasties van die res van die Swartland, wat oorwegend Malmesbury-skalie is.
