
**NATIONAL ENVIRONMENTAL MANAGEMENT: PROTECTED AREAS ACT, 2003
(ACT NO. 57 OF 2003)****CORRECTION NOTICE: MEERKAT NATIONAL PARK DECLARED IN TERMS OF THE NATIONAL ENVIRONMENTAL MANAGEMENT: PROTECTED AREAS ACT, 2003**

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment, under section 20(1)(a)(i) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003) declared the Meerkat National Park, and in terms of section 38(1)(a) assigned the management of the Meerkat National Park to the South African National Parks under Government Notice No. 15, published in the Government Gazette No. 43145 of 27 March 2020.

According to the Surveyor General Diagram File No. F9557/1953, the following Deeds of Transfers, namely T1117/2018, T3318/2017 and T745934/2008, contain inaccurate size description of properties.

I, therefore, correct the size descriptions as they appear in the Schedule to the above-mentioned Government Notice as follows:

- (a) "Remainder of the Farm Swartfontein No. 496, situated in the Kareeberg Municipality, in the Administrative District of Carnarvon, Northern Cape Province and measuring 2288.3240 hectares, held by the Deed of Transfer T1117/2018", as it appears in the Schedule, is substituted with "Remainder of the Farm Swartfontein No. 496, situated in the Kareeberg Municipality, in the Administrative District of Carnarvon, Northern Cape Province and measuring 3234.1240 hectares, held by the Deed of Transfer T1117/2018";
- (b) "Portion 1 of the Farm Swartfontein No. 496, situated in the Kareeberg Municipality, in the Administrative District of Carnarvon, Northern Cape Province and measuring 2288.8077 hectares, held by the Deed of Transfer T3318/2017", as it appears in the Schedule, is substituted with "Remainder of Portion 1 of the Farm Swartfontein No. 496, situated in the Kareeberg Municipality, in the Administrative District of Carnarvon, Northern Cape Province and measuring 2288.8077 hectares, held by the Deed of Transfer T3318/2017"; and
- (c) "Farm Los Berg No. 73, measuring 6534.97 hectares, according to SG No. F4069/1935 held by the Deeds of Transfer T745934/2008", as it appears in the Schedule, is substituted with "Portion 1 of the farm Los Berg No. 73, situated in the Karoo Hoogland Municipality, in the Administrative District of Fraserburg, Northern Cape Province and measuring 1831.5806 hectares, held by the Deeds of Transfer T745934/2008" and "Remainder of the farm Los Berg No. 73, situated in the Karoo Hoogland Municipality, in the Administrative District of Fraserburg, Northern Cape Province and measuring 4703.3903 hectares, held by the Deeds of Transfer T745934/2008".
