# Definitions

 In these Regulations, any word or expression to which a meaning has been assigned in the Act <u>bears that meaning</u> and unless the context indicates otherwise –

"the Act" means the Dental Technicians Act, 19 of 1979; and

"**Regulations**" means Regulations relating to Unmounted Teeth, 1982, published under GN R. 306 of 26 February 1982, as amended by Government Notices No. R. 286 of 15 February 1985, R. 856 of 9 May 1986, R. 669 of 3 April 1987, R. 846 of 28 April 1989 and 340 in GG 44462 of 19 April 2021.

### Amendment of Regulation 1

- 2. Regulation 1 of the Regulations is amended by -
  - 2.1. the substitution for the definition of "dental supplier" of the following definition –

"'dental supplier' means a person who has been issued with a permit in terms of [contemplated in] section 33[(1)(b)] of the Act to supply, sell and to be in possession of unmounted artificial teeth;"

2.2. the deletion of the definition of "dental trader".

#### Amendment of Regulation 4

- 3. Regulation 4 is amended by
  - (1) the substitution for sub-regulation (1) of the following sub-regulation -

"4.(1) The application fee payable to the council [referred to in regulation
1] for a permit shall be [R12,745-00] <u>R13,478-00</u> and such amount shall only be refundable if the council rejects an application for a permit.

- (2) the deletion of sub-regulation (2);
- (3) the substitution for paragraph *(a)* in sub-regulation (3) of the following paragraph:
  - "(a) [R19, 658-00] <u>R22, 245-00</u> in respect of a dental [trader] supplier: or;"
- (4) the deletion of paragraph (b) in sub-regulation (3).
- (5) the substitution for paragraph (b) in sub-regulation (3) of the following paragraph:
  - "(c) a pro rata portion of the fee referred to in sub-regulation 3(a) or
     (b), as the case may be, calculated from the date of issue of the permit, [R4,468-50 in respect of a or dental supplier who is issued with a permit during the course of the financial year] for the unexpired portion of the financial year.".
