- The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received applications from T Mobile SA (Pty) Ltd for the transfer of ownership of its Individual Electronic Communications Service ("I-ECS") and Individual Electronic Communications Network Service ("I-ECNS") licences.
- 2. The applications were submitted in terms of Regulation 11 of the Processes and Procedures Regulations for Individual Licences, 2010, published in Government Gazette No 33293 of 14 June 2010, as amended by the Amendment Individual Processes and Procedures Regulations 2015, published in Government Gazette No 39871 of 30 March 2016 ("Processes and Procedures Regulations"), read with section 13 of the Electronic Communications Act No 36 of 2005, as amended ("the ECA").
- 3. The transfer applications seek approval from the Authority to transfer the I-ECS and I-ECNS licences from T Mobile SA (Pty) Ltd ("the

Applicant") to Telafrica Mobile (Pty) Ltd ("the Transferee") and will be evaluated on the basis of the following criteria:

- a. promotion of competition in the ICT sector;
- b. interests of consumers; and
- c. equity ownership by Historically Disadvantaged Persons ("HDPs").
- 4. The Applicant submits that 100% of the Transferee's equity shareholding is held by HDPs.
- 5. The applications, relevant schedule and any representations received pursuant to this notice will be made available and open for inspection by any interested party in the Authority's library, during the Authority's office hours.
- 6. Any interested party is invited to lodge written representations to the applications within fourteen (14) working days from the date of publication of this notice in the Government Gazette. The Authority will make the applications received available for public review on its website: <a href="https://www.icasa.org.za">www.icasa.org.za</a>.
- 7. Any person who makes written representations must indicate whether they require an opportunity to make oral representations in the event that the Authority decides to hold public hearings.
