The Minister's invitations were published in Government Gazette No. 3332 under Notice No.649, also in the Government Gazette No. 36832 under Notice No. 669, and in Government Gazette No. 36833 under Notice No. 670. In accordance with section 50 of the Astronomy Geographic Advantage Act, 2007 the then Minister of Science and Technology published the Regulations for the Protection of the Karoo Central Astronomy Advantage Areas, in Government Gazette No. 43387 under Notice No. 629 and the Sutherland Central Astronomy Advantage Areas in Government Gazette No. 42492 under Notice No. 805.
