GENERAL NOTICE IN TERMS OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED.

Notice is hereby given in terms of Section 11(1) of the Restitution of Land Rights Act No. 22 of 1994, as amended, that land claims for Restitution of Land Rights have been lodged on the farms R/E, portion 1 & 2 of Vooruitzicht 787 KS, R/E, portion 1, 2 & 3 of Loopspruit 805 KS, Kanaan 322 KS, R/E of Meerlust 804 KS, R/E of Drankenstein 784 KS, and R/E, portion 1 & 2 of Rustplaats 788 KS situated within Sekhukhune District: Limpopo.
