GENERAL NOTICE IN TERMS OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED

Notice is hereby given in terms of Section 11(1) of the Restitution of Land Rights Act, 1994 (Act No. 22 of 1994), as amended, that a land claim for Restitution of Land Rights has been lodged on the properties in the Fetakgomo-Tubatse Local Municipality of Sekhukhune District, of Limpopo Province.

Kgoshi Phauudi Randle Sekhukhune lodged a restitution land claim on behalf of Marota Bogwasha Tribe. The land claim is in respect of portions 0 (Remaining Extent) and 1 of the farm Haakdoornhoek 262 KT, portions 0 (Remaining Extent) and 1 of the farm Kranskloof 131 KT and portions 0 (Remaining Extent), 1, 2, 3, and 4 of the farm Naboomkoppies 263 KT.
